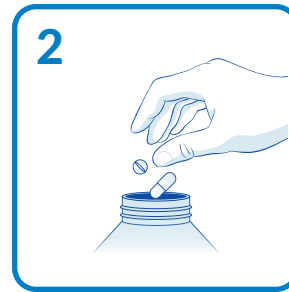

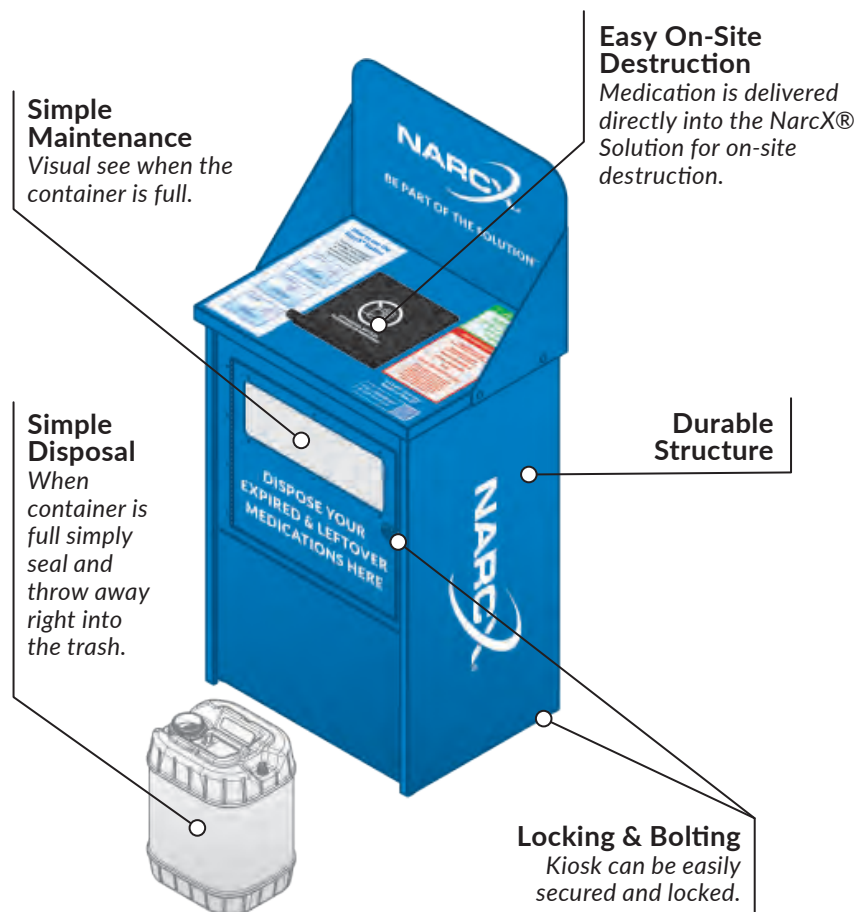

Does NarcX Expire?	NarcX has a 24-month unopened shelf life. We advise in using and disposing of opened NarcX containers after 90 days of opening.
